• <u>Principles of Business Communication</u> (BTW 250)

Format: Face-to-face, Online

An advanced composition course that teaches students to apply the principles of successful professional communication to workplace writing tasks. Students practice editing and supervising the writing of others. Assignments replicate typical business cases and situations, including a report that requires students to compile and interpret research.

• Writing and Research (Rhetoric 105)

Format: Face-to-face, Hybrid

A first-year composition course focusing on source-based academic

writing and rhetorical principles. Introduces students to research-based writing and the construction of academic, argumentative essays that use primary and secondary sources as evidence. Projects include writing a personal narrative, analyzing the rhetoric of editorials, an editorial responding to a current publication, and a final essay that synthesizes sources from the entire semester to draw new conclusions.

• Writing to get that job! (English 199)

Format: Online

Students improve writing skills particularly germane to successfully applying for an internship, a post-baccalaureate job, or an advanced-degree program. Students apply those skills to create a polished set of recruiter-ready texts relevant to their career plans.

• Local Union Leadership:

Format: Face-to-face

Analysis of how local unions are supposed to function. Techniques of effective leadership and conducting meetings will be discussed and demonstrated. Lessons include developing leadership strengths, empowering others as leaders, advocating on behalf of a representative body, and creating action plans.

• Grievance Handling & Processing

Format: Face-to-face

Is it a grievance or a gripe? Students are introduced to labor rights and responsibilities under the grievance procedure. Lessons include introduction to the grievance process, investigation and filing, and collective action around grievance.

• English Composition I (English 1101)

Format: Face-to-face

A first-semester, first-year composition course that develops the basic writing skills required in all college students. Students leave this class with the ability to write clear, correct, organized, and purposeful prose, apply the principles and strategies of argumentation and analysis, and synthesize research in writing so the insights and documentation are logical and clear. Each student should leave this course with the knowledge of how written and oral language connect us to the larger community, and how writing and reading are means for connecting the writer to contemporary culture and its diverse problems and conditions.

• Honors English Composition II (English 1102-H)

Format: Face-to-face

Students read and discuss critically literary texts in playwrighting, poetry, and fiction. Students must also demonstrate writing and research skills beyond that of English 1101 while addressing content and style convincingly and artfully. Thus, students should, by the end of the course, be able to investigate the ideas and effects of a text and write

persuasive papers seeking a new route of inquiry.

• World Literature (English 2110)

Format: Face-to-face

A second-semester, first-year composition that prepares students for entering into the professional literary discourse. Students appraise significant works from a variety of cultural traditions. They examine the historical, social, cultural, and intellectual contexts of these works. Students distinguish qualities of genre and the role of culture in shaping genre.

Students further develop their poetry and prepare for college level workshops and professional publication.

• <u>Prose I: Introduction to Fiction and Non-fiction</u> (Creative Writing) Format: Face-to-face

Students perform tasks that challenge their writing skills, concentration, ideas of the self and audience, while expanding their ability to express ideas through fiction and non-fiction writing.

Introduction to Slam Poetry (Creative Writing)

Format: Face-to-face

This course focuses on the craft of performative poetry and results in a joint public performance with the NMSU Slam Poetry Team.
